I certify that I have read and fully understand the 2018 Upper Darby Marching Royals handbook. I will follow all rules and do my best to meet the expectations of the staff. I understand the consequences if I do not comply with the rules of the organization and staff.

PARTICIPATION DUES AGREEMENT

I understand that I am responsible to pay all student dues as outlined in the 2018 Upper Darby Marching Royals handbook. All dues will be paid in their entirety by Sept 10, 2018. The total fee for returning members is \$250 and for new members is \$340.

UDHS MARCHING ROYALS INSTRUMENTAL & COLOR GUARD UNIFORM CONTRACT

We have read and understand the Upper Darby Marching Royals uniform policy on the back of this paper. We understand that any damage due to neglect or improper use of the assigned uniform or loss of any piece of the uniform is our responsibility and we will be held financially liable.

THE UNIFORM POLICY BELOW IS IMPLEMENTED TO MONITOR THE ASSIGNMENTS AND MAINTENANCE OF THE INSTRUMENTAL AND COLOR GUARD UNIFORMS FOR ALL MEMBERS OF THE UPPER DARBY MARCHING ROYALS.

INSTRUMENTAL -- MARCHING ROYALS UNIFORM INFORMATION

Students will receive the same uniform yearly. Exchanges will be made if clothing is outgrown. Students will be fitted for their uniforms but may not wear their uniform (and therefore may not be permitted to take part in a performance) until both the parent/guardian and student have signed the policy and returned it to a Uniform Parent. If any item is lost, stolen or neglected, you will be responsible for purchasing replacements through the Upper Darby Band Organization of Parents.

Maintenance of the (INSTRUMENTAL) Marching Band Uniforms

1. Do not hand wash or machine wash any part of the marching band uniform items. They are dry clean ONLY.
2. No one is permitted to take home their marching band uniform. There are two exceptions to this rule:
 1. If alterations need to be made to the pant or sleeve length. (Make no permanent changes to uniforms. Hems may be tacked up by hand with matching thread--no machine stitching. NEVER cut uniforms, use staples, or ANY tape adhesives--including duct tape. If in doubt, please ask a band/uniform parent first.)
 2. If the uniform is damp/wet due to rain during a performance, then the uniform must be taken home and pieces should be removed from garment bag, hung up separately until they are completely dry. When uniforms are dry, they should then be hung up properly in their garment bag and returned to the uniform closets at school.
3. If clothing is found to be machine hemmed, if pant bottoms are frayed, or there seems to be any other type of neglect or abuse (intentional or accidental), you will be held responsible and financially liable.
4. Understand that all uniforms will need to be dry cleaned at least once part way through the season. The members will be responsible for taking care of this cleaning. The Director and/or UDBOP will determine when there will be enough time between performances and will then notify members when they should take their uniforms to the dry cleaners.
5. Any time you return your uniform after having it dry cleaned, please put your name on the receipt and place the receipt in the clear "NAME" pocket on the front of the garment bag or give the receipt to a band/uniform parent, so that we have a record that it was cleaned and when.

COLOR GUARD -- MARCHING ROYALS UNIFORM INFORMATION

Students will be measured for their uniforms but may not wear their uniform (and therefore may not be permitted to take part in a performance) until both the parent/guardian and student have signed the policy and returned it to a Uniform Parent. If any item is lost, stolen or neglected, you will be responsible for purchasing replacements through the Upper Darby Band Organization of Parents.

Maintenance of the COLOR GUARD Uniforms

1. PLEASE FOLLOW MANUFACTURER'S WASHING INSTRUCTIONS THAT COME WITH THE UNIFORMS. DO NOT machine or hand wash any part of the color guard uniform items, unless specified in manufacturer's instructions.
2. No one is permitted to take home their color guard uniform. There is one exception to this rule:
 1. If the uniform is damp/wet due to rain during a performance, then the uniform must be taken home and pieces should be removed from garment bag, hung up separately until they are completely dry. When uniforms are dry, they should then be hung up properly in their garment bag and returned to the uniform closets at school.
 2. If the uniform gets dirty, it may be taken home and follow manufacturer's washing instructions. Once cleaned, uniforms should be returned to the uniform closet.
3. If clothing is found to be neglected or abused (intentionally or accidentally), you will be held responsible and financially liable.
4. Understand that all uniforms may need to be cleaned at least once part way through the season. The members will be responsible for taking care of this cleaning. The Director and/or UDBOP will determine when there will be enough time between performances and will then notify members when they should take their uniforms home to be cleaned per manufacturer's instructions.
5. ALL Color Guard Uniforms are the property of the Upper Darby Marching Royals and MUST be returned to the Band Room at the end of the season. However, if a Color Guard member would like to keep their uniform at the end of the season, they may be purchased for a discounted price at the end of the season. (price to be determined).

All students will be measured for and assigned Color Guard Uniform Items each year, which coordinate with the current show's theme. The pieces will vary from year to year depending on the theme.
